Snake Fence - Is it worth it?

Compare Snakebite vs. Barrier

Snakebite:

Exposure to a snakebite depends on many factors: Known rattlesnake activity, proximity to and disturbance of habitat, adult responsibility for others, insufficient focus on surroundings and bad luck are just some of them.

The direct and indirect costs often overlap and can be enormous: *Ongoing medical treatment & costs, loss of income, pain, suffering and disability.*

With timely, modern medical intervention ... the risk of death from a venomous snake bite is very low. The severity of injury &/or disfigurement from a snakebite is moderate-to-significant, with lingering effects & time likely spent in the ICU.

Barrier:

By way of comparison, a hardened rattlesnake barrier typically takes between 1-7 days to install, is a permanent solution and is often less than 1% of the medical cost of snakebite treatment.
